### **Please bring the following when applying:**

1. Completed application
2. FDLE Background check results (must provide a copy of the results)

3. Valid Government photo ID (Driver's License, Passport, ID card)
4. Proof of ability to work in the United State, if not a U.S. citizen.
5. \$50.00 cash or money order

1. Black or Blue ink
2. Legible handwriting
3. Complete all applicant information and Establishment information.
4. Completed questionnaire.
5. Notary section will be completed by the Police Department Clerk.

**An incomplete, incorrect, or non-legible application will be denied. There will NOT be a refund for denied applications.**
